## **HOPE and PELL Maximum Award Amounts**

## Purpose

For the 2023 – 2024 aid year, the maximum HOPE Scholarship and HOPE Grant award per semester at a USG institution increased from \$4,620 to \$5,129. Based on this change, the maximum annual award for the HOPE, HOPECT and HOPEGD fund codes was increased to \$15,400.

The maximum annual award amount for Regents Fund Code 'PELL' was increased from \$10,500 to \$12,000 based on an increase for the 2023 – 2024 aid year.

### **Functionality delivered with this release:**

In this release, the FADM Fund Code lookup table and the associated reference table will be updated for the following Regents Fund Codes and award amounts:

Fund Code	Description	New Max Award Amount
HOPE	HOPE Scholarship	15,400
HOPECT	HOPE Grants – Certificate / Diploma	15,400
HOPEGD	HOPE Grants – GED	15,400
PELL	Pell Grant	12,000

The FADM Fund Code maximum award amount is used by the following validation in evaluating awards per student for each fund code:

• VFNA030: Max Amount Awarded must be valid for the Regents Fund Code Submitted.



## SBGI Field Size

## Purpose

To update the SBGI field size change from 6 to 20 characters for the FADC 2324 Aid Year. In Spring of 2023 Ellucian expanded the field size of the Source Background Institution Code (SBGI) codes from 6 to 20 characters. The length of FA Applicant Tracking SBGI CODE (RRRAREQ\_SBGI\_CODE) was increased to 20 characters in the Financial Aid DED. Thus, the entry for data element FNT018 was updated. The column SBGI\_CODE was updated in the ODS and PDC FADM\_FASFA\_MIMIC tables and the related table dump reports.
