



2.00 RELEASE NOTES

Augusta University Financials release 2.00, which is scheduled to be applied on Feb. 28, 2025, includes the following updates:

- Upgrade to PeopleTools 8.61.
- Minor update to the TIGA Salary and Travel process.
- Modification to Lease and Payment start and end date requirements
- Table changes that may affect third-party integrations.

Note that there are no major changes to the User Interface.

<p>Known Issue: Issue When using Type Ahead/Autocomplete Functionality</p>	<p>Following Release 6.00, an Oracle bug affects the Type Ahead/Autocomplete functionality for search fields containing a comma. When utilizing a search field containing a comma, PeopleSoft will display ::: characters instead of the comma. If users select the search result, an error message may display, or the search result may return a "No matching values were found" message.</p> <p>For more information, see KI9.2.173.Other: Issue when using Type Ahead/Autocomplete functionality.</p>
<p>Known Issue: Issue with "Notify" Button Functionality</p>	<p>Following Release 6.00 an Oracle bug exists that affects the "Notify" button, which is present on many pages across the system. Table changes

Release 2.00 includes table changes that may affect third-party integrations. ITS recommends that all institutions using institution-specific integrations such as SAS, Business Objects, or other reporting software test these integrations prior to the release.

Institution resources responsible for local integrations and reporting may notice the new fields (table columns) in the database. ITS is not changing any business process or PeopleSoft Financials functionality as a result of these table changes.

TIGA BORIF01A/B/C report update	<p>Navigation: BOR Menus > BOR GL > BOR GL Interfaces > DOAA Reporting > TIGA Salary and Travel > Create Salary and Travel File</p> <p>Issue: When attempting to run the BORIF01A process, it would run to error due to an employee's name containing more than 40 characters.</p> <p>Solution: Changed field from NAME1 to NAME to increase the length of the field for BORIF01A, BORIF01B and BORIF01C processes.</p>

<p>Creating New or Maintaining Existing Payable Lease</p>	<p>Navigation: Nav>Asset Management>Asset Transactions>Leased Assets>Create New Payables Lease or Maintain Payables Lease</p> <p>A modification was added which allows the payment start and end dates and lease start and end dates to differ.</p> <p>Previously, when adding a lease with a payment type of Arrears, users had to enter a zero dollar payment row, where the payment start and end dates matched the lease start and end dates. This zero dollar payment row is no longer necessary, and users can now enter the actual payment dates.</p>
